What is the history of the G20?

Originated in 1999 at the level of Finance Ministers and Central Bank Governors, the G20 gathered for high-level discussions on macro-financial issues.

In the wake of the 2008 global financial crisis, the G20 was elevated to include the leaders of member countries. The first G20 Leaders' Summit took place in Washington D.C. in November 2008.

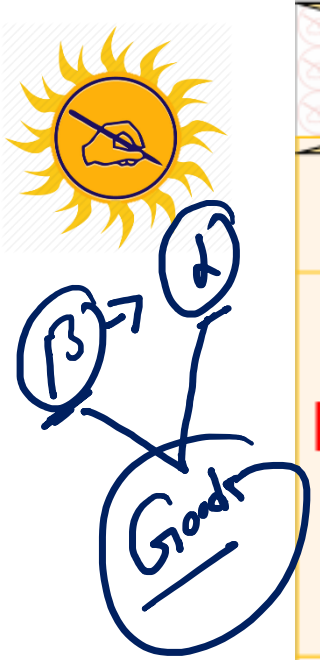

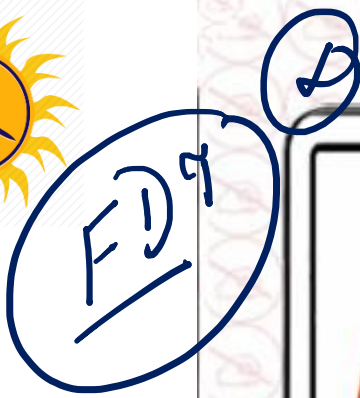

- g) Manufacturing of cigars, cheroots, cigarillos and cigarettes.

Under the Automatic Route, the non-resident investor or the Indian company does not require any approval from Government of India for the investment.

Under the Government Route, prior approval of the Government of India is required. Proposals for foreign investment under Government route, are considered by concerned Administrative Ministries / Departments.

Foreign Investment Promotion Board (FIPB) abolished by Government order dated the 5th June 2017



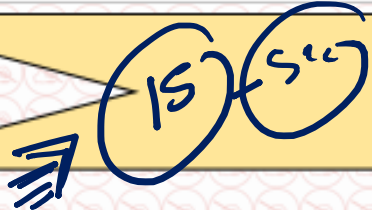
