Recruitment of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-Inspectors in CISF Examination, 2017 - Declaration of Result of Paper-II for short listing candidates for Medical Examination.

The Staff Selection Commission conducted a Computer based Examination for recruitment of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-Inspectors in CISF Examination, 2017(Paper-I) from 01.07.2017 to 07.07.2017. The result of Paper-I was declared by the Commission on 06.09.2017. Paper-II of the said Examination was held on 15.12.2017 for those candidates who qualified in PET/PST.

2. Based on the cut-off fixed by the Commission (Paper-I +Paper-II), category-wise details of the candidates qualifying for appearing in Medical Examination are as under :-

6. The category status in respect of the candidates belonging to reserve categories has been indicated along with their roll numbers. It is important for such candidates to note that they have been declared qualified only for the category mentioned against their Roll Number. If his/her actual category does not match, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to contact immediately the respective Regional Offices of the Commission in all such cases, if they face any such issue.
